From the Desk of the President

The NAFT leadership, along with the leadership from the other town unions, recently met with the North Attleboro Selectmen to negotiate changes in health insurance.

The selectmen offered the unions two health insurance proposals for FY10. One proposal resulted in an increase in premiums of 9.55% for the HMO and 12.5% for the PPO, with co-pays and plans remaining the same. The other plan resulted in an increase of 0% for the HMO and 4.58% increase for the PPO with a tremendous increase in co-pays to union members. For example:

- Inpatient hospitalization would increase from \$250 to \$500
- Day surgery would increase from \$0 to \$250
- Emergency room visits would increase from \$50 to \$100
- CT scans and MRIs would increase from \$0 to \$75
- Office visits would increase from \$15 to \$25
- Prescriptions would increase as follows:
 - o *Generic:*
From \$10 to \$15 (pharmacy) and \$30 (mail away)
 - o *Preferred:*
From \$20 to \$30 (pharmacy) and \$60 (mail away)
 - o *Non-Preferred:*
From \$35 to \$50 (pharmacy) and \$150 (mail away)

Selectmen provided the unions with the cost of the increased co-pays to our members. The increased out-of pocket expenses for union members would be \$475,995 per year.

Management did offer a mitigation fund, which would reimburse the increase to co-pays for a period of 3 years. After careful consideration of the health insurance offerings, union leaders unanimously agreed to keep health insurance plans the same and take the increase to the premiums versus a year with lower premiums with a cost shift of co-pays to members. The cost shift of co-pays would expose members to undue financial stress. While management did offer a mitigation fund, after year one, members would continue to incur increases in health insurance premiums. When the mitigation fund expired, union members would be burdened with the substantial increase in co-pays as well as premiums. With the current economy, union leaders were not willing to expose their members to increased premiums and increased co-pays.

Health Insurance and Collective Bargaining

City and town managements are seeking to have sole control over plans offered, deductibles, co-pays, and premium payment.

This proposal eliminates collective bargaining about health insurance issues. Others want the city and town managements to determine unilaterally whether to have all employees obtain health insurance coverage through the Group Insurance Commission (GIC) which the state manages. This proposal seriously curtails collective bargaining about health insurance issues.
